Reni, described by his contemporary criticism (Malvasia) as an almost divine figure for his artistry, ran his studio with a rigor and precision that reflected his dedication to art: the organization of his workspace, the techniques used and the interaction with his collaborators.

AT THE WIDESPREAD COURT OF THE DIVINE GUIDO



- •Carlo Cesare Malvasia describes Guido Reni's career in his work "Felsina Pittrice".
- •Guido Reni, known as "Divino Guido", preferred to spend on charity rather than invest in real estate.
- •Reni was known to be unpredictable and to live surrounded by a court of pupils, merchants, bankers, doctors, poets and musicians.
- •Malvasia emphasizes the management of Reni's home and studio, often in different locations, and his living outside the common rules.
- •The "Plague Altarpiece", a long commission, highlights the difficulty of dealing with Reni without the intervention of senators and aristocrats

CAREER AND PERSONALITY OF GUIDO RENI



- •Reni's studio was divided into several locations and categories of apprentices and students.
- •Reni had exceptional charisma, attracting many young artists who paid to be able to work near him.
- •Francesco Gessi, Giovan Giacomo Sementi and Giovanni Andrea Sirani were among his closest and most trusted pupils, called "masters of the chamber".
- •Giovanni Andrea Sirani kept Reni's "Libro dei Conti" and "Memorie di casa" up to date

ORGANIZATION OF THE STUDY



- •Upon Reni's death, the debts with the entourage had to be settled, and the repayments to the clients managed.
- •Giulio Cesare Conventi, master of the chamber of the cardinal legate, and other trustees such as Simone Tassi and Saulo Guidotti held works by Reni.
- •The notary Giulio Cesare Sturoli and Reni's collaborators, such as Marco Bandinelli and Francesco Gazzini, guaranteed the transfer of assets.
- •Reni's will, dictated in the presence of Saulo Guidotti, freed Guido Signorini, cousin and designated heir, from some debts.

DEBTS AND PROPERTY



- •Lorenzo Loli, known as "Lorenzino del Signor Guido", and Giovanni Andrea Sirani made claims on some of Reni's works.
- •Paintings owned by the trustees included "Liberality and Modesty", two Sibyls, a "Judgment of Paris" and others.
- •Patrons such as Giulio Cesare Conventi, Malatesta Albani and Ludovico Orazi had works in their possession that had to be returned or finalized.

COLLABORATORS OF RENI



- •Guido Reni's death had a significant impact on his pupils, such as Domenico Maria Canuti, who fell into a severe depression.
- •The importance of Reni's figure in the lives of his students was such as to cause strong emotional reactions to his death.
